Privacy policy for Volkswagen AG Conference Call / Webcast Q3 2022

A. Controller

We are delighted that you will be participating in the Conference Call / Webcast Q3 2022 ("web conference") of Volkswagen AG, Berliner Ring 2, 38440 Wolfsburg, lhre-Daten@volkswagen-kommunikation.de, registered in the commercial register at the Braunschweig Local Court under the number HRB 100484 ("Volkswagen AG"). In the following, we inform you about the processing of your personal data by Volkswagen AG in connection with your participation in the web conference.

B. Processing of your personal data

I. Invitation to the web conference, mailing of information on participation

We process your email address/first name/last name/media or company name ("contact data") provided by you in the context of your registration in our master database or of business correspondence in order to send you an invitation to the web conference and – prior to the web conference or, where applicable, upon acceptance of the invitation – the necessary login information, in particular a link to the web conference solution.

II. Participation in the web conference

1. Accessing the web conference solution; call center

With our invitation you have received a link and a telephone number. The link will take you to a website of Volkswagen AG, Wolfsburg. By calling up the website you can follow the web conference. In order to be able to ask additional questions, please use the telephone number specified in the invitation. With the website and the telephone dial-in, EQS Group AG, München, provides the technical requirements to be able to follow the conference or to actively participate. By calling up the page or calling the call center EQS Group AG, München, receives personal data from you. Volkswagen AG has no influence on the data collected by EQS Group AG, München, and its further processing. The purpose and scope of the data collection and the further processing and use of the data by EQS Group AG, München, as well as your rights in this regard and setting options for the protection of your privacy can be found in the data protection declarations on the website of EQS Group AG, München.

2. Processing of interaction data

In the context of this web conference, we enable your interactive participation on the basis of the following interaction option:

Asking questions by phone

You can ask your questions live by phone. Invited media representatives, analysts and investors will be informed of the relevant phone number in good time. Some of the questions submitted will be taken up and answered. Invited media representatives, analysts and investors putting their questions via the dial-in phone number will be addressed by name and requested to put their question live by phone during the web conference. Volkswagen will reply to selected questions during the web conference orally. In order to respond to your question(s) during the web conference and for transmission and recording, we only process the actual question(s) and your first name, last name and the media/company as provided by you.

Your personal data are processed to enable optimal interactive participation in the web conference.

Please note the following:

When you actively engage in the web conference, other participants and Volkswagen AG may take note of your contributions. Moreover, the recording and dissemination of the web conference by other participants cannot be ruled out. Depending on the participants, your data may be accessible worldwide, also in countries with a lower level of data protection than the European Union. You are advised to take particular care in making sure that you do not unintentionally impart information that is not relevant to participation in the web conference. The data processed in the context of holding the web conference is stored for a period of 3 years and subsequently erased, unless a different storage period is required by law (e.g., storage period as required by tax law) or there is some other legal basis.

3. Recording of the web conference

We record the web conference for documentation purposes as audio file. You can access this recording via our Group website in the Financial Calendar <u>link</u> on demand post-web conference. The recording is erased after a period of 3 years if there is no legal ground for a longer storage period. As a general rule, one exception is the permanent storage in the Corporate Archives of documents which are relevant to the company and of historical importance. As a general rule, recordings of web conferences may be stored for an unlimited period for such archiving purposes.

III. Legal grounds for data processing

We process your data in connection with the holding of the web conference on the basis of the following legal grounds:

1. For the performance of a contract (Art. 6 para. 1 lit. b, GDPR) when we offer you the web conference in the context of a service we provide for you.

- 2. For carrying out an employment contract (Section 26, Federal Data Protection Act (FDPA)), if you participate in the web conference as part of your duties as an employee of Volkswagen AG, respectively for the performance of a contract (Art. 6 para. 1 lit. b, GDPR) in the capacity of an executive body pursuant to the German Stock Corporation Act, and therefore not in the capacity of an employee as defined in Section 26 (8), FDPA.
- 3. On the basis of your consent (Art. 6 para. 1 lit. a, Art. 7, GDPR), if
 - We use your contact data provided by you in the context of your registration in our master database in order to send you information on the web conference and to issue an invitation. Further information on processing your data in connection with our master database and our email mailing lists is available here link.

IV. Use of processors

We use the processors listed below to hold the web conference. Data processors process personal data solely according to our instructions and on the basis of a data processing agreement.

1. Service provider for the web conference solution; call center

We have commissioned EQS Group AG, München, with the provision of the following web conference solution link and the call center.

2. Service provider for audio recording the web conference

AVI-Studio – Audio-visuelle Informationssysteme GmbH, Hannover, provides us with support for the audio recording .

C. Your rights

You may assert the following rights against Volkswagen AG at any time on a free-of-charge basis. For further information concerning the exercise of your rights, please refer to section D.

Right of access: You have the right to receive information from us on the processing of your personal data (Art. 15, GDPR).

Right to rectification: You have the right to obtain the rectification of inaccurate or incomplete personal data concerning you from us (Art. 16, GDPR).

Right to erasure: You have the right to obtain the erasure of your data where the conditions set out in Art. 17, GDPR are met. Accordingly, you may, for example, obtain the erasure of your data if it is no longer necessary for the purposes for which it was collected. In addition, you can obtain erasure if we process your data on the basis of your consent and you revoke this consent.

Right to restriction of processing: You have the right to obtain the restriction of processing of your data if the conditions of Art. 18, GDPR are met. This is the case, for example, if you dispute the accuracy of your data. For the duration of the verification of the accuracy of the data, you may obtain restriction of processing.

Right to object: If the processing takes place on grounds of the legitimate interests of Volkswagen AG or a third party, or is in the public interest or in the exercise of an official authority, you have the right to object to the processing of your data on grounds relating to your particular situation. In the event of objection, we ask you to inform us of your reasons for objecting to the data processing. In addition, you have the right to object to data processing for direct marketing purposes without giving reasons. This also applies to profiling to the extent that it is related to the direct marketing.

Right to data portability: If the data processing is carried out on the basis of consent or the performance of a contract and this is also done using automated processing, you have the right to receive your data in a structured, commonly used and machine-readable format and to transmit it to another data processor (Art. 20, GDPR).

Right of revocation: If the data processing is based on consent, you have the right to revoke the consent free of charge at any time with effect for the future.

Right to lodge a complaint: You also have the right to lodge a complaint with a supervisory authority (e.g., with the State Data Protection Officer for Lower Saxony, Germany) regarding our processing of your data.
